In 2015 we furthered those aims via: the completion of a large-scale scientific impact evaluation of our infrastructure improvement program; provision of safe infrastructure around nine high-risk primary schools in Tanzania; road safety education in primary schools to over 100,000 children in 10 countries in sub-Saharan Africa; the social marketing of reflector-enhanced schoolbags; government advocacy for road safety; and more.
